Selection Procedures

A. Selection Process:

1. Interested candidates shall submit detailed resume highlighting their qualification & experience along requisite application as per the prescribed format and self-attested copy of associated certificates to the office of the undersigned.
2. Applications shall be screened and those who match the essential qualification & minimum experience criteria shall be invited for interview. Please note that qualification or experience shall not be considered without supporting documents such as qualification certificate/degree & proof of relevant work experience.
3. Original certificates is to be carried on the date of interview which is subject to verification.
4. After interview, list of selected candidates shall be finalized based on the scoring pattern described below.

B. Selection shall be based on the following scoring pattern:

1. Qualification & Academics: Total marks: 50

10 marks each for 10th, 12th & Graduation result. (On proportionate basis. For ex: in case, marks obtained in 12th is 80%, 8 marks shall be awarded)

10 marks for result of the professional degree basis which essential qualification is achieved.

5 marks shall be allocated for every additional degree/diploma/certificate in the associated field attained over and above the qualifications mentioned in qualification criteria. The additional qualification should be achieved post obtaining essential qualification for such marks.

2. Experience: Total marks: 35

3 marks shall be allocated for every completed year of experience.

Additional 1 mark shall be allocated for every completed year of Health Sector experience.

Further additional 1 mark shall be allocated for every completed year of experience in Govt. /State Corporation/Listed Company.

Cutoff date for considering experience shall be 1.1.18.

C. Interview: 15 marks-

Candidates shall be judged on various parameters such as domain knowledge, experience, interpersonal & associated skills.
